




JASPERS Resources



In-house experts in 6 regional offices

- Staff count: around 130
- Fast access to external consultants
 via Framework Contracts
- Multi-lingual, multi-cultural and multi-disciplinary teams
- Proximity to beneficiaries reduces response time and facilitates knowledge sharing
- Knowledge of local situation allows better understanding of key issues related to projects
- Relevant expertise from regional offices can be mobilised elsewhere



JASPERS Support to Urban



- Eligibility: consistency with EU priorities & urban strategies and meeting exante conditions
 - EU 2020 strategy, Territorial & Urban Strategy, Cohesion Policy, ESIF Regulation
 - Compliance to EU procurement, climate action, environmental and social protocols and state aid
- Urban development: <u>ERDF Article 7 on Sustainable Urban Development</u>
- Smart city development: <u>Smart Specialisation Strategy</u> (RIS3).
- JASPERS advisory support: strategic advice, horizontal assignments and preparation of projects, programmes and schemes
 - Project costs for large urban schemes are at least EUR 50m, for medium-sized schemes it is between EUR 25m and EUR 50m, for small schemes it is below EUR 25m.



JASPERS support to Urban



- Urban development projects or programmes
 - Planning-led
 - Integrated Sustainable Urban Development Strategy
 - Smart Grids Investment Support Strategy
 - Smart Specialisation Strategy
 - Sustainable Urban Mobility Plans
 - Multi-dimensional
 - Multi-sectoral

Assistance to Malta's Integrated Sustainable Urban Development Strategy



- Supporting the Managing Authority (OP I ERDF-CF)
- Urban strategy covers culture, housing, education and tourism
- Complementarity with ESF and other actions
- Estimated total cost of urban scheme: EUR 24m
- Scope of JASPERS intervention:
 - Review of the draft Strategy with a view to ensure coherence among objectives
 - Methodological support to prioritise projects
 - Review final documents provided by consultant(s)
